

## **THE PEDAL TAIWAN VIRTUAL CYCLING RACE TERMS AND CONDITIONS**

These are the terms and conditions (the "Agreement") for your participation in the Pedal Taiwan VCR. By registering for the Pedal Taiwan VCR you agree to these terms, which form a binding legal contract between Pedal Taiwan and the registered participant ("you"). If you are registering on behalf of another individual, it is your responsibility to make that person aware of what these terms are and that they accept them. By completing the registration on behalf of another person you are confirming that you have made the participant aware of these terms and that they have accepted them.

### **1. Participant requirements**

1.1 Costs. All costs associated with the attendance of you, the participant, shall be covered entirely by the individual, you, and will not be attributable to Pedal Taiwan. This includes the purchase of any equipment(s) that may be necessary to compete in the event.

1.2 Personal injury. Pedal Taiwan will not be responsible for any direct injuries that occur before, during, or after the Pedal Taiwan VCR. You should be responsible for your own safety while competing and should read the safety information for the equipment(s) being used.

1.3 Property damage. Any damage that may occur to any bit of equipment or structure will not be the responsibility of Pedal Taiwan. You should ensure there is plenty of space to use any equipment needed for the Pedal Taiwan VCR in order to reduce the chances of anything being damaged.

## 2. Prizes

2.1 All prizes will be provided by Pedal Taiwan or the sponsors of the Pedal Taiwan VCR. All prizes are set to the specific finishing position and are therefore non negotiable, swappable, or changeable.

## 3. Registration and withdrawal

3.1 All information provided as part of the signing up process will only be used for communication purposes. Pedal Taiwan abides by relevant local legislation, including the General Data Protection Regulations, which is all outlined in the companies Privacy Policy (accessible at: <https://pedaltaiwan.com/wp-content/uploads/2020/08/Pedal-Taiwan-Privacy-Policy.pdf>) This includes what information we collect, how we use it, and we store it.

3.2 If you wish to withdraw from the event for any reason, unless explicitly stated, your information will be kept in the Pedal Taiwan database for future marketing purposes. You can unsubscribe from any Pedal Taiwan mail lists by just pressing the unsubscribe button on any of our emails.

## 4. Live Finals

4.1 All finalists must abide by the venues health and safety policies in order to ensure the safety of everyone at the event.

4.2 Disruptive conduct. Pedal Taiwan reserves the right to disqualify or prevent any participant from taking part in the live finals in the case of them displaying disruptive, offensive or antisocial behaviours.

4.3 If any finalists are under the age of 16 then an accompanying parent or guardian must be in attendance with this individual.

4.4 Digital Content. Pedal Taiwan will be producing videography of the Live Finals event which is likely to include footage of all finalists. Unless having been explicitly told not to, Pedal Taiwan will assume all participants are willing to be part of the videography.
